A JOINT RESOLUTION OF THE CITY COUNCILS OF THE CITY OF CAMARILLO  
AND THE CITY OF OXNARD AND THE COUNTY OF VENTURA  
ESTABLISHING A GREENBELT BETWEEN  
AND NORTH AND SOUTH OF THE TWO CITIES

WHEREAS, a greenbelt can be defined as an area consisting of prime agricultural or other open space land, as defined in Section 35046 and 65560 of the Government Code, which is preserved in agricultural or other open space uses; and

WHEREAS, the City Councils of the City of Camarillo and the City of Oxnard and the Board of Supervisors of the County of Ventura encourage the preservation of open space and agricultural uses wherever possible; and

WHEREAS, the area lying generally northeast, east, and southeast of the City of Oxnard and northwest, west, and south of the City of Camarillo is difficult for either of the cities or the County to service with sewers, water, police, fire and other municipal services, and is now devoted to agricultural pursuits; and this open space assists in providing community identity, definition and character in keeping with the objective of controlling urban sprawl; and

WHEREAS, all the community and regional plans designate the area for agricultural and open space uses, and the area is excluded from all city spheres of influence; and

WHEREAS the City Councils of the Cities of Camarillo and Oxnard and the Board of Supervisors of the County of Ventura hereby find that the lands in this area are worthy of retention in agricultural and other open space uses for the overall best interests of the cities, the County, and the State.


NOW, THEREFORE, BE IT RESOLVED, that the Camarillo City Council, the Oxnard City Council, and the Ventura County Board of Supervisors hereby establish this greenbelt for and agree to a policy of non-annexation, non-development and retention of open space uses for the territory between the Cities of Camarillo and Oxnard as shown on the map attached as Exhibit 2 of this resolution.


BE IT FURTHER RESOLVED that should incorporated land within the Del Norte area be detached from the City of Oxnard and become unincorporated land, that area shall be included in the greenbelt established by this resolution without further action by the parties hereto; and that should the boundaries of the Cities' Spheres of Influence be amended, the boundaries of this greenbelt may be amended; but should incorporated land be detached from the City of Camarillo, such land shall not be included in this greenbelt unless the City of Camarillo takes action to include it in the greenbelt.

BE IT FURTHER RESOLVED that the Local Agency Formation Commission is requested to endorse the greenbelt and to continue to act in a manner consistent with the preservation of the aforementioned lands for agricultural and other open space purposes.

The clerks are directed to send a certified copy of this resolution to the Local Agency Formation Commission.




